ADDITIONAL CONDITIONS

THE ORDERING PARTY WILL REJECT BID OFFERS THAT:

- a. Have been prepared in a way contrary to the requirements stipulated in the paragraph "PROCEDURE FOR BID OFFER PREPARATION" hereto,
- b. Are incomplete - do not contain all the documents requested from offerers as described in the point "List of documents/representations required from Contractors" hereto,
- c. Have shorter bid offer validity period than the period required under the Request for Proposal,
- d. Have been submitted after the deadline for submission of bid offers.

The offer that has been rejected or submitted by an offerer, who was previously excluded from the procurement procedure, will not be evaluated.

PROCEDURE FOR BID OFFER PREPARATION

- 1) The Bid Offer must be prepared in writing, **in Polish or English language** - type scripted or computerised.
- 2) Bid offer validity period shall not be shorter than until 01.06.2017.
- 3) The bid offer must contain at least the following information:
 - a) Data of the offerer;
 - b) Bid offer preparation date;
 - c) Bid offer validity period;
 - d) Net and gross price specification.

DISCLAIMERS

1. Partial bid offers will be excluded from the procedure.
2. Offerers shall prepare and submit bid offers at their own cost and economic risk.
3. Bid offers and attachments thereto will not be returned to offerers.
4. This Request for Proposal does not oblige the Ordering Party to enter into contract or to commence negotiations.
5. The Ordering Party reserves the right to invalidate or close the tender procedure at any time, without stating reasons, including without selecting the most favourable bid offer.
6. The offerer is not entitled to any claims against the Ordering Party in case of rejecting its bid offers or excluding the offerer from the tender procedure.

BID OFFER EVALUATION

EVALUATION CRITERIA AND DESCRIPTION OF SCORING SYSTEM

Bid offers will be evaluated by the Contractor Selection Committee appointed by the Company's Management Board.

The Ordering Party will use the following criteria for selection of bid offers:

BID OFFER EVALUATION CRITERIA

Points in this criterion shall be given according to the following:

1. Price - up to 80 points

Points in this criterion shall be given according to the following:

$$C = (C_n / C_o) * 80$$

Where:

C_n – net price of the most favourable bid offer

C_o – net price of the bid offer being evaluated

2. Size of the space to be leased - 20 points

- Exhibition space 16 m² – 20 points,
- Exhibition space above 16 m² to 19 m² – 10 points,
- Exhibition space above 19 m² – 0 points,

The Ordering Party will select the bid offer with the highest score as the most favourable one.

INFORMATION ON SELECTION OF THE MOST FAVOURABLE BID OFFER

The Ordering Party will inform all offerers about selection of the most favourable offer

- I. through e-mails sent to the e-mail address indicated by the offerer in its bid offer or via mail,
- II. through the Beneficiary's website.

EXCLUSIONS

THE ORDERING PARTY SHALL EXCLUDE FROM THE TENDER PROCEDURE THE CONTRACTOR, WHO:

- I. Has personal or capital relationships with the Ordering Party. Personal or legal relationship shall be interpreted as mutual relationship between the Beneficiary or persons authorised to undertake legal obligations on behalf of the Beneficiary or persons performing activities connected with preparation and processing of selection of Contractors on behalf of the Beneficiary, and the Contractor, involving in particular:
 - a. participation in a company as a shareholder of a private partnership or partnership;
